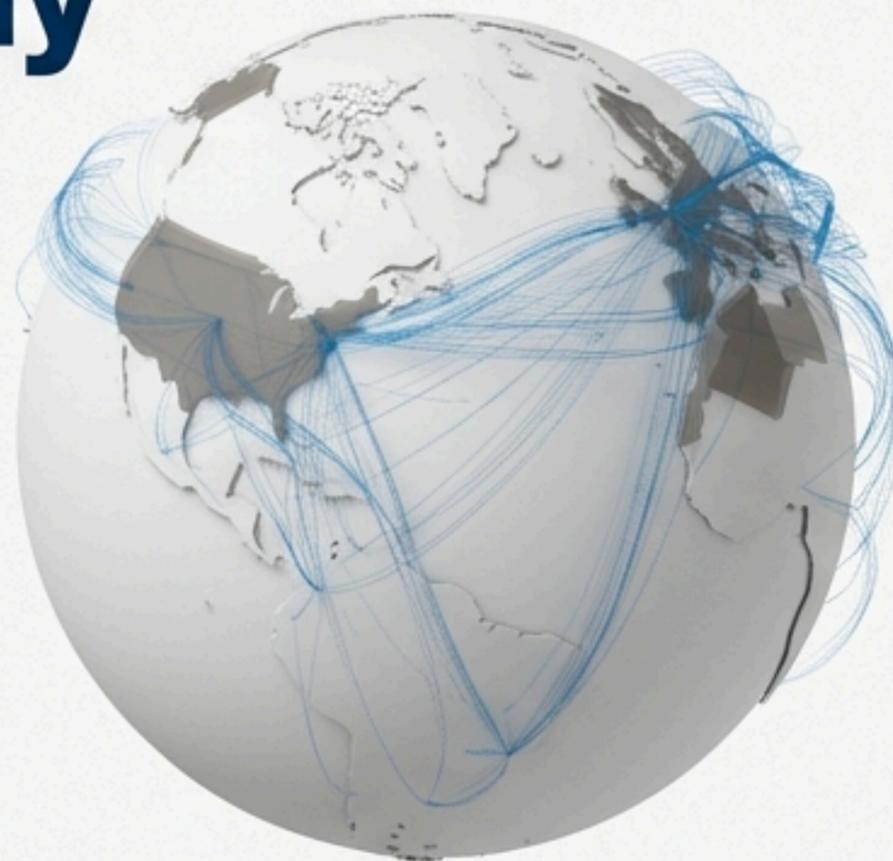

High Stakes: The constant pressure to protect public health and the ethical obligation to “do safety” right.

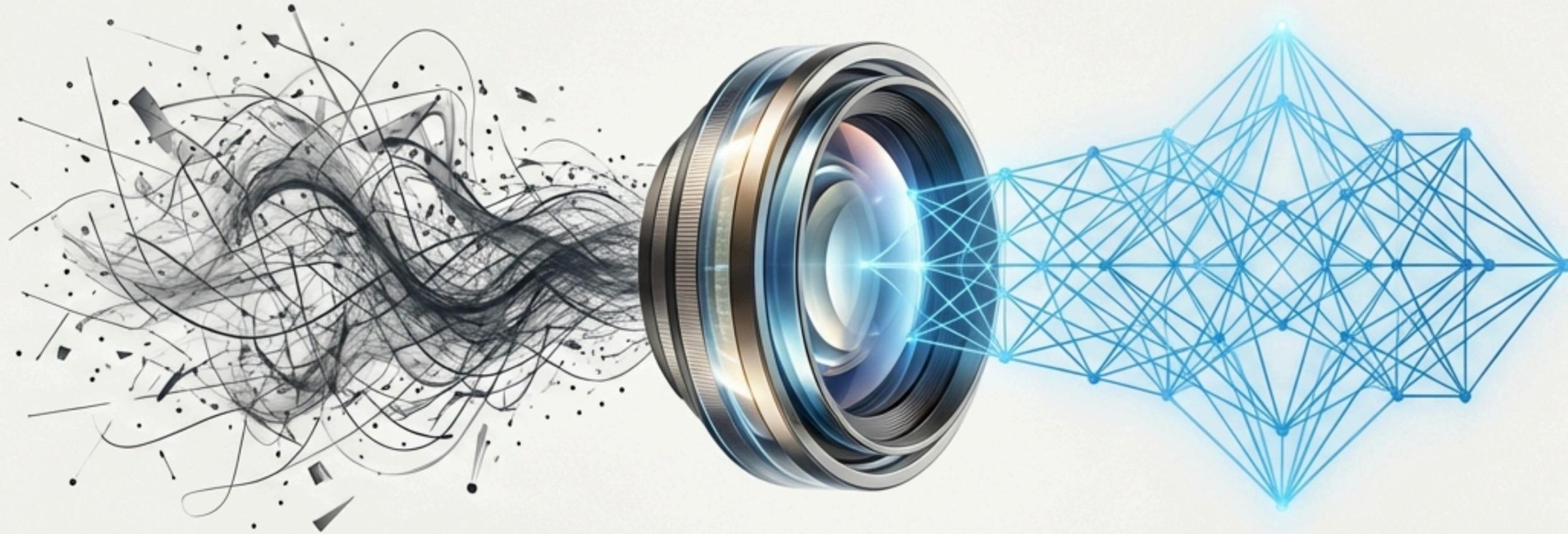
Finding the Signal in the Noise

A Necessary Evolution

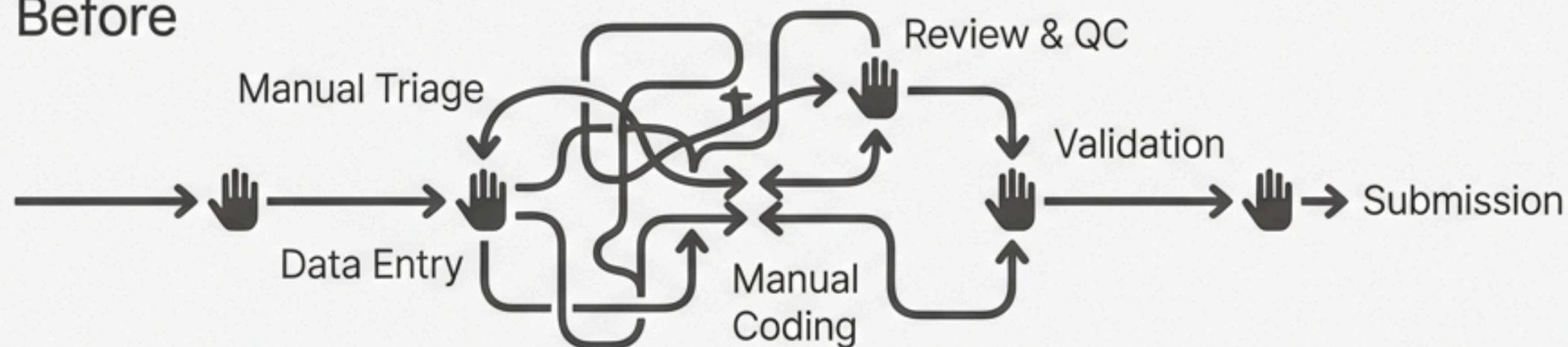


Artificial Intelligence is moving from the fringe to the forefront, offering practical solutions for core PV tasks.

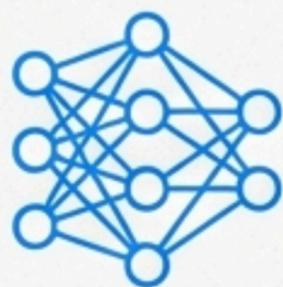

ML algorithms analyze vast datasets to uncover subtle safety signals missed by traditional methods.

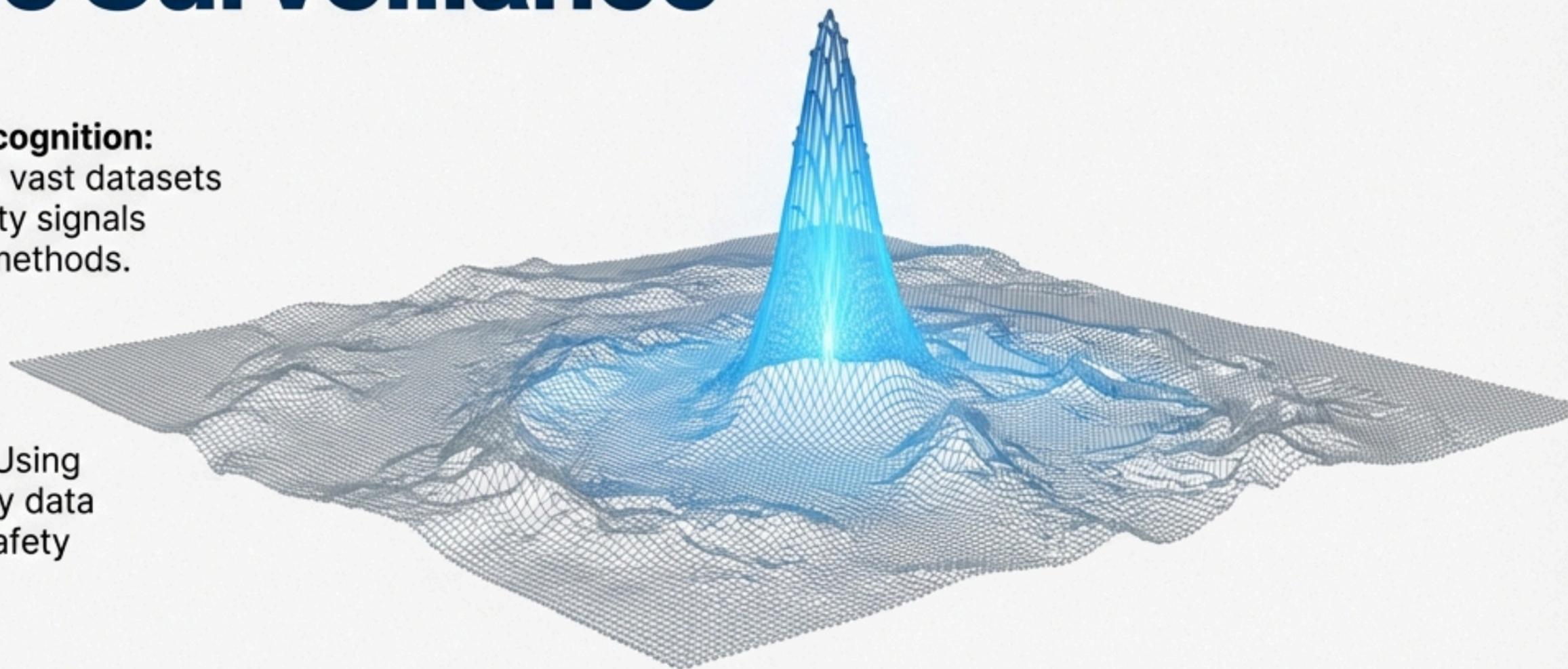


Predictive Modeling: Using pharmacoepidemiology data to forecast potential safety issues.

Ethical Oversight

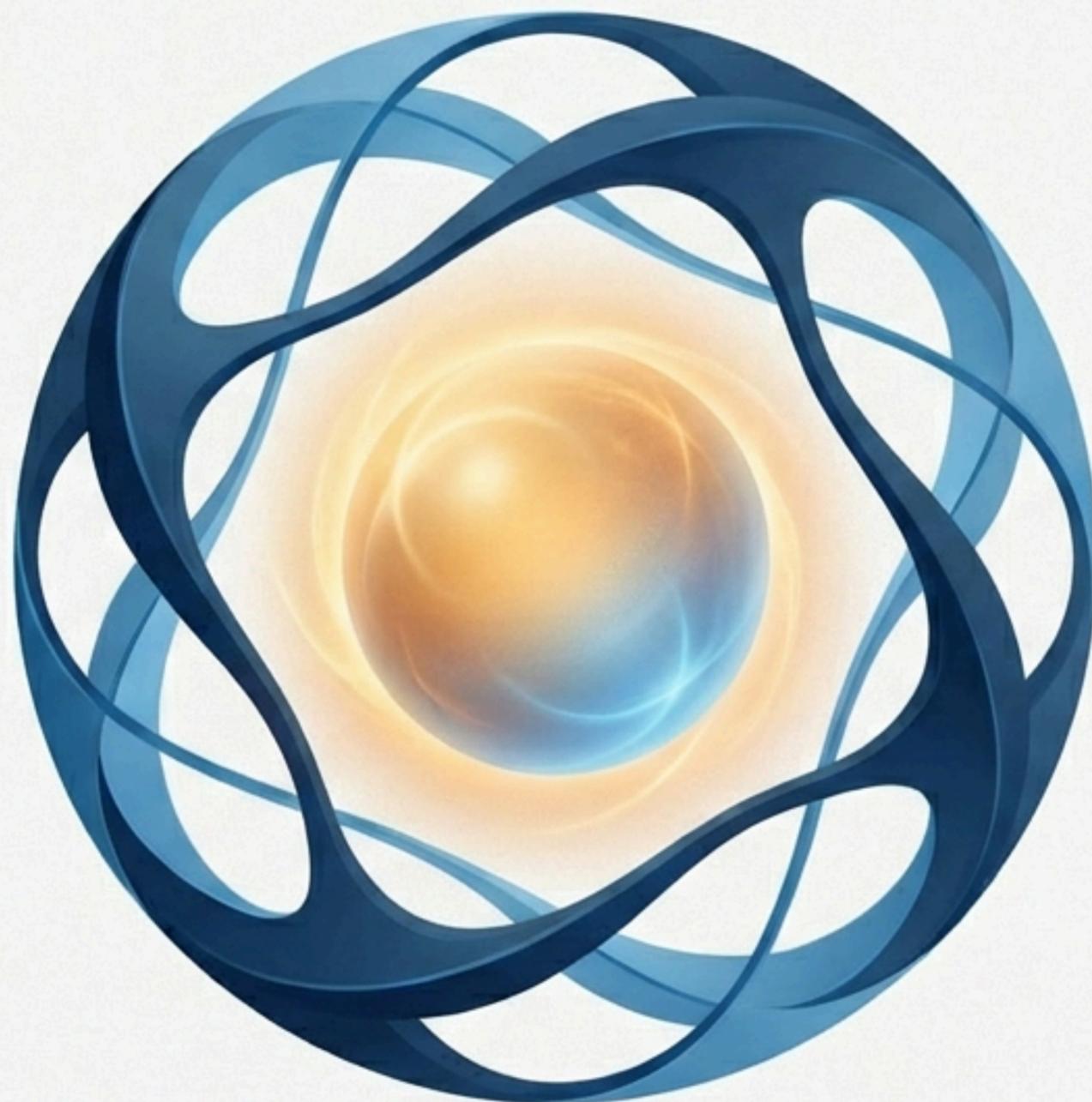
Ethical Oversight:
